THE PRC IS A COMMUNITY RESOURCE FOR WOMEN/MEN IN UNPLANNED PREGNANCIES. THE PRC'S CARING CONFIDENTIAL, AND FREE SERVICES INCLUDED; MEDICAL RESOURCES INCLUDE PREGNANCY TESTING, LIMITED ULTRASOUND EXAMS, OPTIONS COUNSELING, PARENTING CLASSES, POST-ABORTION COUNSELING, FATHER MENTORING, AND RESOURCES INCLUDING CLOTHING, EQUIPMENT, SUPPLIES, ETC. IN 2014 THE PRC SERVED 644 UNIQUE CLIENTS WITHIN 1,357 APPOINTMENTS. THIS INCLUDED PROVIDING 519 PARENTING CLASSES, 200 SHOPPING FOR RESOURCES (FOR FREE), 459 PREGNANCY TESTS, AND 395 ULTRASOUND EXAMS.
