THE ORGANIZATION'S CARING, CONFIDENTIAL, AND FREE SERVICES INCLUDE MEDICAL RESOURCES (PREGNANCY VERIFICATION AND LIMITED ULTRASOUND EXAMS), OPTIONS COUNSELING, PARENTING CLASSES, POST-ABORTION COUNSELING, FATHER MENTORING, REFERRALS, AND RESOURCES (CLOTHING, SUPPLIES, AND EQUIPMENT). THE ORGANIZATION ALSO PROVIDES AN ABSTINENCE EDUCATION PROGRAM TO MIDDLE AND HIGH SCHOOLS, AND TO COMMUNITY ORGANIZATIONS SUCH AS THE LOCAL DETENTION CENTER.
